Why become a Life Member in Perpetuity (LMIP):

1. You no longer pay annual dues, so future dues increases will not affect you.

2. Your Lodge will receive an assessment credit from Grand Lodge every year —forever—even after you pass to the Celestial Lodge.

3. You receive a permanent membership card, certificate, and pin.

The cost of a LMIP is determined by multiplying annual dues (\$107.00) by 16, so a LMIP in 2017 costs \$1,712.00. You must also be CURRENT (paid your dues) for the year in which you apply for LMIP. Please contact the Secretary if you have not received your dues card or for more information.
